► Message received from **HE Marcus Cornaro** at the end of this meeting:

“

I am delighted to have been able to receive at the Delegation of the European Union your President, Mr. Toumi and your Secretary General, Mr. Goaid, and the opportunity offered to me to address you in this way, until a more favorable period makes it possible to meet in greater numbers.

Indeed, contact with European entrepreneurs established in Tunisia, or even Tunisian companies wishing to orient themselves towards European markets, constitutes one of the very enriching facets of my mission. It is not only a personal interest in the creativity, the audacity, the know-how that you deploy, but one of the strong institutional axes of my mission.

Trade is a pillar of the Tunisian-European relationship, and the trade section of the Association Agreement has governed the trade relationship between Tunisia and the European Union since its signature in 1995.

The European Union is by far Tunisia's largest trading partner and Tunisian exports to the European Union have tripled between 1995 and 2020. In certain sectors, such as agricultural products (2019) or services, the balance is tilted towards favor of Tunisia.

A stable economic relationship is obviously built around investments. I would like to remind you here that 85% of Foreign Direct Investments in Tunisia come from the European Union. It is also a leading employer, covering 81% of the total employment created by FDI.

It is therefore a dense economic relationship and a complex and evolving European economic diplomacy. We believe that the legal framework of the trade relationship should evolve to support, even more than today, the integration of Tunisia into value chains and the diversification of its economy.

Each of you are involved in these economic exchanges. You are witnesses both to daily harassment and to large or small advances, individual or collective. Your field experience is invaluable to us at the Delegation of the European Union in several respects: to identify systemic problems that must be resolved by dialoguing with the authorities, but also to detect future projects or trends that deserve all our attention and support.

It is in this sense that I am delighted with the relationship established today with your Chamber, whose openness to strengthening cooperation at European level and pragmatism can only be an asset, for you and for us »

EBRD and Attijari bank sign 20M€ risk sharing mechanism Agreement



The EBRD and Attijari bank Tunisie have signed an agreement on a risk-sharing mechanism for an amount of € 20 million, as well as an Agreement (standards of the International Swaps and Derivatives Association (ISDA)).

These agreements, signed by Mr. A. Sallé de Chou, Head of the EBRD Office in Tunisia and **Mr. S. Sebti, CEO of Attijari bank Tunisia**, aim to facilitate access to finance for Tunisian small and medium-sized enterprises.



- ▶ **Prime Minister Hichem Mechichi** announced on January 16th the reshuffle of his Government, which includes 11 new Ministers.
- ▶ **83% of Tunisians** consider that the economic situation has deteriorated in 10 years.
- ▶ **The Minister of Economy, Finance and Investment Support**, Mr. Ali Kooli, indicated that the revision of the compensation system, the reduction of the wage bill and the restructuring of public enterprises were the main government projects in 2021.
- ▶ **The Central Bank of Tunisia (BCT)** should put in place specific financing during the first quarter of 2021 for the financing and restructuring of fragile businesses.
- ▶ **Call for applications** was launched for the ENLIEN project to support Tunisian entrepreneurship, funded by the French Development Agency (AFD).
- ▶ **The Central Pharmacy of Tunisia (PCT)** increased the price of certain imported drugs by 20% in order to restore its financial equilibrium.
- ▶ **The Swiss authorities** have announced that the vast majority of the assets of the clan of former President Ben Ali and his relatives will remain blocked in Switzerland.
- ▶ **The Ministry of Industry, Energy and Mines** has issued agreements in principle to 15 self-generated power generation projects.

Revision of corporate tax rates and their setting at 15%: Article 14

The Pandemic Recession: An Opportunity for the Tunisian Economy

The Covid-19 pandemic has plunged the global economy into a puzzling recession that is likely to last until 2022 and beyond. The coronavirus reached 2,232,000 deaths worldwide (as per January 31st, 2021) since its appearance in China in December 2019. The global gross domestic product (GDP) has also seen a decline of around 4.3% in 2020 compared to the previous year.

For sure, the world that will emerge from this crisis will be different from the one that preceded it, but the impacts and time of recovery remain the biggest uncertainties!

Nevertheless, the current crisis has urged the regulators and organizations to align and adapt with the new conditions, on one hand, and to embrace the new trends such as the digital transformation and energy transition, on the other hand.

However, this pandemic recession could become a unique opportunity for the business development and international trade that would convert into an economic regeneration, especially for developing countries such as Tunisia.

Indeed, with the disruption of agri-food supplies and the reincarnation of industrial centralization in favor of the globalization, Tunisia will be able to position itself as a suitable candidate to support the needs of the European market, first because of its proximity and second because of its low labor costs, considered competitive enough to attract the investments.

In fact, the Covid could trigger the establishment of a new historic era for humanity, and Tunisia should take advantage of it!

To conquer the European market, it is essential to improve the quality and sustainability of the products. And the state must play the role of facilitator through its standardizations and governance.

The organic food products are a good example, as by adapting and establishing a system that examines their compliance with the European norms throughout the value chain, the Tunisian exports could blossom.

The renewable energies and recycling, being themselves sustainable solutions, could be considered post-Covid opportunities. The awareness and new behavior of individuals with regards to the pollution and the consequences of the global warming, have helped shape their transition.

Indeed, ecological awareness, stimulated and accelerated by the Covid, has encouraged companies to think about the welfare.



By readjusting their visions and strategies to mitigate their environmental, economic, and social impacts, and in solidarity with the governments, entrepreneurs will ensure the sustainability of their business vis-à-vis investors and communities, improving their employability, life comfort and therefore their well-being.

A country like Tunisia can profit from this crisis if it succeeds to manage well its resources and waste. Developing pilot projects supported by attractive subsidies could facilitate and accelerate their adoption.

By introducing the energy transition into the post-pandemic recovery process, Tunisia will be able to meet its energy deficit and reduce its external dependence. The digital transformation, if widespread whether in the public or private sector, would absorb a big amount of computer science (IT) graduates and would participate, in addition to the renewable energies, circular economy as well as organic farming, to the creation of thousands of jobs and improve the well-being of the population. This will help to bring back the long-awaited socio-economic stability prompting the thriving of the country.

A call to the government, regulators, entrepreneurs, and investors to consider this pandemic crisis as an opportunity to solve the socio-economic problems of Tunisia!

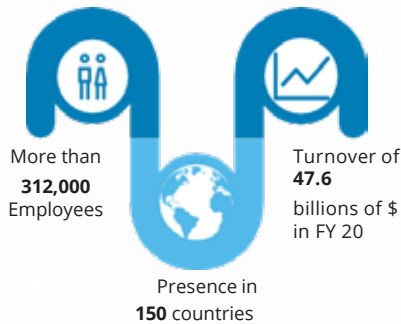

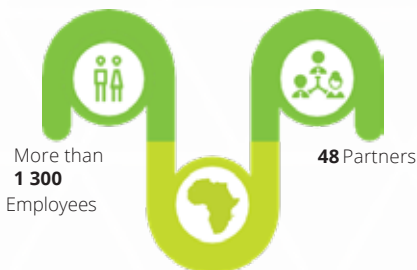
